693. Hospital At	693.1 SM introduced himself as a GP by background and presented on the Hospital at
Home	Home service (HAH) (using previously circulated slides), noting that until December
	2023 this was previously known as the Urgent Community Response Service.
	693.2 Key points; UK is behind rest of the world on HAH where it has been running for
	the last 10 years. Designed to keep people at home that would otherwise be admitted
	to hospital. In GM this avoids approximately 1000 hospital bed days with 98-99% of
	patients given the choice, preferring to be seen at home. HAH is a safer service,
	reducing the risk of infection. Known gaps – diagnostics that could be done at home.

694. CO & Chair's	694.1 AL provided further detail on the previously circulated report.
Reports	694.2 AL informed members that there were currently some issues with cross
	boundary working between HWinGM and that work was ongoing to resolve these. HF
	noted the number of services that were now shared between Manchester and Trafford
	and the need for HWT to access services delivering to Trafford patients.
	694.3 AL informed members that the bid to HW England (HWE) to conduct an Enter & View visit to Manchester & Trafford CDC service had been successful and the visit had now been conducted. HWT had also been approached by Trafford ICP to assist in engagement work on the Trafford Locality Plan Refresh with both initiatives generating contracted income. 694.4 BH asked about updates on the Urgent Care Review (UCR) in Trafford? HF responded and noted that part of the Locality Plan refresh had identified the UCR as a priority but it was likely that this work would be on hold until after the local elections in May 2024.BH asked if the Walk In Centre at Trafford General Hospital (TGH) was under review as part of the UCR? HF responded that it wasn't at this stage. 694.5 HF informed members that UCR recommendations will go to GMICB for further action but noted that Altrincham Minor Injuries Unit (AMIU) does not meet NICE guidelines.
	694.6 HF informed members that she had put forward Autism and ADHD services and pathways for Children and Young People (CYP) as a priority for the Locality Plan Refresh.
	694.7 HF noted that staffing issues at ICB level had now been resolved, although it was still not clear exactly who would be responsible for what. Huge financial issues still remained, and work was ongoing to save money wherever possible. GM was one of the worst performing ICS in the country.
	694.8 GMMH/Edenfield Report; HF informed members that the findings of the report had resulted in action plans to be worked through.
	694.9 HF felt that the CDC E&V went very well and had thanked Bolu for his work on it.
	694.10 JR queried whether SRFT could refer Trafford patients back to Trafford Social
	Services? Action: HF to check with Karen Ahmed
